



WHEREAS The following signatories/trustees to this deed of trust has been running a trust at Building Number 125 of Ward No. XII Padiyoor Gramma Panchayath since the year 2008 by creating an endowment by setting apart and establishing a fund for the public educational and welfare and charitable objectives and purposes in all Kerala basis as per the mutual understanding and now it is decided to reduce the same into writing and register the same before the concerned registrar office with the same terms and conditions which is mentioned below.

I. NAME OF THE TRUST:

The name of the Trust shall be "HOMELANDS EDUCATION AND RESEARCH TRUST", a charitable trust for the empowerment of the society".

II REGISTERED OFFICE:

The registered Office of the Trust shall be continued to function hereafter at Building No: 125, Ward #12, Padiyur Gramma Panchayath, Pedeyankode, Of Irikkur-Iritty State Highway, Irikkur P. O, Kannur District, Pin 670 593, or at such place or places as the trustees by majority from time to time may agree upon and the trustees may open more offices than one at the same time in different part of operation.

III AREA OF OPERATION

- 1) The area of operation of the Trust shall be the state of Kerala in particular territory of India in general with particular emphasis on the condition and problem of down trodden.
- 2) The trust may start any branches, extensions or institutions in any foreign country and / or may enter into any collaboration, adjustments or under standings with any foreign institutions.

IV. OBJECTIVES OF THE TRUST:

(A):

(1) To establish, take over, and maintain development centers such as Nursery schools, cultural centers, children's Library, Day care, Hobby clubs, etc., for children.

(2) To establish, takeover, and maintain educational institutions such as primary and high schools, Professional Colleges, Science and Arts colleges, Industrial Training centers, Technical education centers, Computer training centers, Academic Coaching centers, etc.

(3) To set up career and employment guidance centers to enable students and youths in finding better educational facilities and employment opportunities.

(4) To create and maintain database for academic, economic, and health related data for the population in Irikkur and the neighboring areas.

(5) To establish centers for research and studies in the socio-economic, health, educational and cultural aspects and to propagates the thoughts and visions of great scholars, philosophers and conduct researches in the various subjects.

(6) To setup, maintain, and manage hostels, educational and recreational activity centers, for the welfare of the students.

(7) To promote education by providing facilities of scholarships to deserving students studying in the institutions of the Trust and elsewhere in such manner as may from time to time be deemed proper by the governing body of the Trust.

(8) To provide financial and professional assistance to promote the standard of living, educational and vocational interest among the weaker section of the society.

(9) To conduct periodic discussions, seminars, workshops, in the educational and cultural part of the society so that the linguistic and cultural unity and harmony of various sections are upheld and to cultivate a healthy civic sense, love of public property and discipline.

- (10) To organize and manages education and career fests, competitions, conferences and seminars, etc. in all concerned fields.
- (11) To setup libraries and publish periodicals, pamphlets and other literature relating to cultural and social development.
- (12) To give guidance and extend assistance to the artisans and to those engaged in traditional crafts by starting cottage and small-scale industries.
- (13) To promote interest in fine arts, sports and games, drama, music, literature, embroidery, tailoring, small scale industry, recreation, computer technology, etc. among the people.
- (14) To setup Orphanage, Centers for handicapped and mentally retarded, Family Counseling centers, Medical camps, Health centers, Hospitals etc. for the benefit of the society.
- (15) To receive funds by way of subscriptions, donations, grants, loans and other offerings and to deal with such funds for the purpose of the Trust.
- (16) To take or give on lease movable or immovable properties and to acquire by purchase, exchange or otherwise, lands and buildings for the objectives of the Trust, to construct new buildings and to sale, exchange mortgage, lease, manage, develop, improve and generally to deal with all or any of the objectives herein mentioned.
- (17) To invest the funds of the Trust in such manner, as the governing body may from time to time deem advisable, the governing body having full authority to invest money and endowments in ways other than those recognized by the Indian Trust Act.
- (18) To carry out Business including agency line or any kinds decided by the governing body of the Trust from time to time, for earning money to further charitable activities of the Trust.

(19) To establish necessary media infrastructure under the auspicious of the Trust to promote the activities.

(20) To do such other and further things as may be incidental or conducive to the attainment or the carrying out of all or any of the above objectives.

(B):

If any one or more of the objectives specified in clause IV (a) above of these presents are held not to be objectives of public charitable nature, the Trustees shall not carry out such objectives as if the same are not incorporated in these presents but the validity of the Trust created by these presents as a Trust for public charitable purpose shall not be affected in any manner.

V. TRUST FUND:

The Trustees signing hereunder had come together for the above objectives and constituted themselves into Trust making an initial contribution of ₹ 5,000/- (Rupees Five Thousand Only) each equally for the Trust fund totaling to ₹ 15,000/- (Rupees Fifteen Thousand Only) with an intent to part with all their rights, title and interest, claim therein and vest the same in the Trustees to have and to hold the same and the investment or the investments for the time being representing the same and all other properties that may for the time being represent the Trust estate together with all additions and accretions hereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the Trust hereinafter referred to as the "The Trust Fund" for the charitable objectives and purposes mentioned above with the powers and on the terms and conditions herein contained of and concerning the same.

VI. BOARD OF TRUSTEES:

Signatories to these presents shall be the first Trustees. The trustees will have the right to co-opt any person by consensus of all or by 2/3rd majority of total strength of the Board of Trustees and the Board shall be constituted Trust Board is as under:



- A) Maximum number of trustees in the Board shall be 20 Twenty and minimum 3 three.
- B) Appointment of Trustees shall be for life.
- C) No person being—
- (a) an undischarged insolvent; or
 - (b) convicted of an offence involving moral turpitude; or
 - (c) of unsound mind; or
 - (d) a minor;
- shall be eligible to be a trustee.
- D) The power to appoint new or additional TRUSTEES, but so as not to exceed the maximum number and to fill vacancies in the office of the trustees, shall vest in the continuing trustee or trustees.
- E) A person shall cease to be a trustee in any of the following events:
- (a) if he dies; or
 - (b) if he becomes bankrupt; or
 - (c) if he becomes insane or otherwise become incapable to act; or
 - (d) if he resigns his office.
 - (e) if he removed or discharged as per clause VI (H)
- F) Office of a Trustee may fall vacant on the death of the Trustee, or resignation incapacity or insolvency, and when there is vacancy, the same can be filled by the then Trustees by making appointment of any suitable and Qualified person.
- G) The Board of Trustees shall be the supreme authority of the Trust, and all other authorities shall act and operate under the supervision of the Trustees and have and exercise such powers, as may be delegated to such authority by the Board of Trustees.
- H) The Board of Trustees may, by a unanimous vote of all the TRUSTEES for the time being except the trustee proposed to be removed or discharged, remove or discharge any trustee, permanently or otherwise, from office after finding the trustee proposed to be removed guilty of serious misconduct in

relation to or concerning the trust estate or trust affairs, or found to have acted adversely to the terms laid down in this deed in such away causing injury to the integrity of the trust or convicted by the court of law for commission of any of the cognizable offence and after arriving at a definite conclusion that for the reasons to be recorded in writing, the continuance of the trustee proposed to be removed or discharged as trustee or these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed or discharged a full and fair opportunity of explaining his conduct and/or the charges levelled against him for his removal or discharge. And the decision of the Board of TRUSTEES in this behalf shall be final and binding on the removed or discharged trustees.

I) Mr. Nizar Keethadath Puthiyapurayil shall be the Chairman, Mr. Anees Pallipath shall be the vice chairman, while Mr. Abdul Raoof Pallipath shall be the Secretary, and Mr. Shamsudheen C. P shall be the Joint. Secretary and Mr. Miraj Kaniyarakkal Thaikkandi shall be the Treasurer of the trust initially for three years and after three years new office bearers can be elected by simple majority. The existing office bearers can be re-elected for many times.

J) The day-to-day functions of the trust and all its activities shall be the sole responsibility of the chairman and he shall be accountable for all such acts done by him in pursuance of the powers thus vested in him.


K) The Treasurer shall exclusively control all financial matters of the Trust and he shall be accountable for all such acts done by him in pursuance of the power, thus vested in him.

VII) NOMINATED TRUSTEES

The following persons are nominated as trustees of this Trust. They will have the same rights and duties alike other trustees.

VIII. MEETINGS:

- (a) The Board of Trustees shall meet at least once in **Three months**. However there may be more frequent meetings, if considered proper.
- (b) Meetings shall be called by the Secretary or may be requisitioned by anyone
- (c) Agenda of the meeting shall be circulated at least three days in advance.
- (d) The Chairman shall ordinarily be the President of such meetings and in his absence, the vice Chairman or Treasurer shall preside over such meetings.
- (e) In case of emergency, the Secretary may call urgent meeting of the Board of Trustees with notice of shorter duration or may even circulate urgent resolution.

- (f) All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote.
- (g) Quorum of the Board meeting shall be 2/3. However, if a meeting is adjourned for want of Quorum the same may take place on any other date and place and the restriction of quorum shall not apply for such adjourned meeting.
- (h) The minutes of the proceedings of every meeting of the Board of Trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall deem so entered and signed be conclusive evidence of the business and other matters transacted at such meetings.

VIII. POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES:

The Board of Trustees shall have the following functions:

- (i) To borrow if needed be against the security of the assets of the trust by way of Bank overdrafts, loans or otherwise, as may be necessary for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents, deeds, papers, etc. as may be necessary in connection there with.
- (ii) To arrange for and/or authorize the signing or execution of any agreement, contract, instrument or any other paper or writing required to signed or executed on behalf of the trustees by any two of the trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- (iii) To appoint or make provision for the appointment of a Sub-Committee of trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

(iv) To authorize any one or more trustees to hold any property of any fund or any investment of the trust subject to such terms and conditions, rules and regulations as the Board of Trustees may from time to time think fit and proper.

(v) To spend any portion of the corpus or the income of the trust fund For purchasing any land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and/or executing any or all of the objects of the trust.

(vi) Generally, the chairman shall have power to represent the trust in all matters and the chairman, secretary and the treasurer are authorized to open bank account in the name of the Trust. They shall operate the bank account and shall issue cheques.

(vii) The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties.

(viii) The trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force time to time and to convert, alter, vary, dispose off or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in sub section (3) of Section 13 of Income Tax Act, 1961 or any subsequent amendments as may be made from time to time.

(ix) If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income Tax Act, 1961 shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the object of the trust.

(x) The trustees shall be at liberty to sell by consensus of all or by 2/3rd majority of the total strength of the Board of Trustees such portion or portions of the movable or immovable properties forming part of the Estate of Trust either by public auction or by private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasional thereby and execute all conveyances or other assurances and to pass valid and effectual receipt and discharges for all moneys received by them.

(xi) The trustees shall keep an account or accounts with any bank or banks, to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution the chairman, the secretary and treasurer to operate bank accounts and to issue cheques, the cheques shall be valid if it is signed by any one of among the chairman or secretary and the treasurer jointly. However, if the cheque amount is five lakh and above all the all signatories shall sign the cheque jointly.

(xii) The trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against loss or damages by fire and may incur all other costs, charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the trust as they may in their absolute discretion think fit.

(xiii) The trustees may manage or supervise the management of any lands, hereditaments and premises for the time being comprised in the trust estate or any part thereof with power to erect, pull down, re-build, add to, alter and repair and fences and otherwise to improve and develop and to cultivate or cause to be cultivated all or any of the said lands, hereditaments and premises and to insure houses and buildings against loss or damages by fire and/or other risks or to let, lease, made allowances to and arrangements with tenants, agriculturists and

generally to deal with the said lands, hereditaments and premises as they may deem fit in their absolute discretion.

(xiv) The trust board may appoint office secretaries, managers, lawyers, Solicitors, auditors, architects, engineers, surveyors, gomstas or other employees and office bearers for the purpose of management and supervision of the trust estate, for collection of rents, deposits, effects and profits for keeping the accounts and records and for other purpose of the trust.

(xv) The board of trustees may appoint any of the trustees as an employee of the Trust to take up specific responsibilities in lieu of salary to meet varying requirements for the functioning of the Trust

(xvi) The trustees may demise the immovable property or properties for the time being and from time to time belonging to the trust there from year to year or for any fixed term or for any term of years or on monthly tenancies at such rent and subject to such covenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

(xvii) The trustees shall have full power to compromise or compound all actions, suits and other proceedings and settle differences and disputes touching the trust estate and/or the trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or the trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.

(xviii) The trustees may take any plot of land or building on lease for any period on the terms and conditions agreed with the landlord and to build the building as permanent or temporary structure or any amenities for running a school or any other business, to make any improvements, to negotiate in good faith such changes in tenure, rental, decoration, to amend the lease agreement if there is any change in laws and regulation, to pay rent and obtain receipt for the same, to issue

and receive notice to or from the landlord, to apply for and obtain any license for running school or any other business in the leased plot or buildings with in the objectives of the trust, to renew the lease agreement from time to time, to sign all the papers related to lease and to vacate and hand over the plot and building(s) to the landlord on the expiry date, provided that the Landlord may or may not pay the tenant any compensation or other amount whatsoever.

(xix) The trustees may from time to time frame schemes and rules and regulations to carryout the objectives of the trust and otherwise for giving effect to the objectives and purposes of the trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper.

(xx) The receipts granted by the trustees or anyone or more of them for any moneys, stocks, funds, shares, securities or investments paid, delivered or transferred to them in exercise of the trust or powers hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.

(xxi) The trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and re-start any charity or charitable institution, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the trust property or income for any particular object or objects.

(xxii) The trustees may reimburse themselves and pay and discharge out of the trust fund all expenses incurred by them in or about the execution of the trust duty or any of their duties under these presents including traveling expenses, but will not entitled to any remuneration.

(xxiii) The trustees shall from time to time after meeting the expenses of and incidental to the management of the trust decide the particular objectives for which the income or corpus of the trust fund or properties for the time being available shall be applied.

(xxiii) The trustees may accept any donation or contribution in cash or in any kind from any person, firm, company, corporation, association, institutions or other trusts for the furtherance of the object or objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may also take over the management of any other charitable trust or public institutions on such terms as they think fit and may manage such institutions and may be treated as the trust properties.

IX. The financial year of the trust shall end on 31st March every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper. The accounts of the trust shall be regularly maintained every year and a Qualified Chartered Accountant shall audit it.

X. On a new or additional trustee being appointed and on signifying his acceptance in writing to the effect of his accepting the appointment, the trust property shall automatically vest in him along with the other trustees for the time being and he will be entitled to carryout all the duties and functions of a trustee without any other deed or writing.

XI. The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust. All the movables and immovable properties lying in the name of above trust shall be continued to be the asset of above said trust.

XII. The trust is an irrevocable one. The chairman and the trustees have no power to revoke it except by 2/3rd majority decision of existing board of trustees. The trustees may join, cooperate and amalgamate the trust with any trusts, institutions having allied and/or similar objectives upon such terms and as they may in their absolute discretion think fit. If any occurrence for dissolution or revocation is happened it can or may sell all movable and immovable properties after revocation of the trust to meet all liabilities of the trust. In the event of dissolution / winding up of the trust the assets remaining as on the date of

dissolution shall not under the circumstances be distributed among the trustees but the same shall be transferred to another charitable trust/society whose objects are similar to those of this trust and which enjoys recognition under 80 G of the Income Tax Act.

XIII. The investment of the funds of the trust shall be utilized, invested in accordance with the provisions of the section 11 (5) read with section 13(1) (d) of the Income Tax Act.

XIV The Board of trustees has power to amend / add / delete any paragraphs of the Trust deed by a 2/3rd majority subject to the prior approval of the commissioner of Income Tax. If powers to effect amendment to the trust deed have been given to the trustees it would not extend to alter the basic character / objects of the trust and further such amendment which may prove to be repugnant to the provisions of section 2 (15), 11 and 13 and 80 G of Income Tax Act shall be made.


XV. The benefits of the trust shall be open to all irrespective of caste, religion, sex, etc.
